You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

#### **The Smart Plan™ Cremation Service Package**

**\$2,550**

Direct cremation is the disposition of the body by cremation, without the added cost of embalming, formal viewing or ceremony. Our charges include the basic services of the funeral director and staff, transportation of the deceased within our service area (75 mile radius of Beneficiary's legal residence within the Continental United States) to our licensed holding and crematory facility, use of a positive identification system, filing of a death certificate and necessary permits, assistance with filing for benefits through Social Security and the Veterans Administration (if applicable), refrigeration, the cremation process, minimal cremation container, earth-friendly wooden Smart urn, Smart Guidebook, Smart Online Obituary; and non-witness scattering at sea, or delivery of cremated remains to local cemetery or residence (within 75 mile radius).

#### **Transportation Service Package**

**\$599**

Out of area service is offered under separate agreement with SafelyHome Protection, LLC. Coverage begins immediately upon purchase. In the event death occurs 75 miles or more from the beneficiary's legal residence, SafelyHome, acting as your personal representative, will facilitate all of the above described service and required merchandise at no additional charge. **Smart Cremation must be notified first upon death.**

#### **Basic Plan Cremation Service Package**

**\$2,101**

Direct cremation is the disposition of the body by cremation, without the added cost of embalming, formal viewing or ceremony. Our charges include the basic services of the funeral director and staff, transportation of the deceased within our service area (75 mile radius of Beneficiary's legal residence within the Continental United States) to our licensed holding and crematory facility, use of a positive identification system, filing of a death certificate and necessary permits, assistance with filing for benefits through Social Security and the Veterans Administration (if applicable), refrigeration, the cremation process, minimal cremation container, wooden urn with photo frame, Smart Guidebook, online obituary; and non-witness scattering at sea, or delivery of cremated remains to local cemetery or residence (within 75 mile radius).

If you elect NOT to purchase a package above, but prefer to pay full retail as indicated by the prices below, then these ranges apply:

Direct Cremation	\$1,800 - \$5,375
Our full retail charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; refrigeration; transportation to crematory; necessary authorizations; and cremation.	
A. Direct Cremation with Container Provided by Purchaser	\$1,600
B. Direct Cremation with Alternative Container	\$1,800

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering.) The containers we provide are cardboard. Smart Cremation does not offer caskets for sale or rental.

“Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.”

*Basic Services of Funeral Director and Staff	\$649
This fee for our <b>basic services</b> and <b>overhead</b> will be added to the total cost of the cremation arrangements you select. This charge includes, but is not limited to availability of staff 24 hours a day, staff and facilities to respond to initial requests for services, use of a positive identification system, consultation with responsible party to determine services desired, coordinating service plans with cemetery, crematory and/ or other parties involved in final disposition of the deceased, filing of local death certificate and obtaining local permits, providing assistance in filing social security notification form and veteran forms (if applicable).
